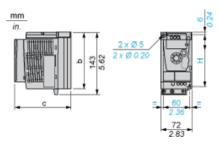



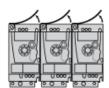
Clearance for Vertical Mounting

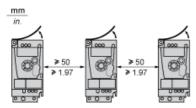




Single-Phase Power Supply Wiring Diagram



2-Wire Control for Logic I/O with Internal Power Supply




LI1 : Forward LI• : Reverse A1 : Drive


Analog Input Configured for Voltage with Internal Power Supply


Analog Input Configured for Current with Internal Power Supply



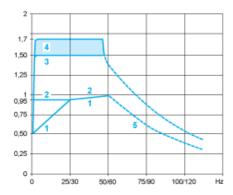
